1. Consent Agenda (Mark Bishop)

# 2. Approval of Interpretation of Ends and Metrics (Michelle)

- Rev. Jennifer presented updates to Ends 5 and 8 on the basis of the discussion at the board meeting in October.
  - End 5 was updated to include that building awareness of Unitarian Universalism, our church and our values will provide opportunities to increase membership.
  - End 8 was updated to include intentional outreach in welcoming.
- After a brief discussion the board agreed that the Ends were reasonable and complete.
- Detailed metrics will be reviewed in January.

#### 3. Sources of Authority Discussion (con't) (Michelle)

- Michelle presented a summary of sources of authority from other UU churches and the UUA.
- The board discussed what the most important elements to include in our sources of authority. At the most basic level there was consensus on the categories below:

  - Future Members and Children
  - Past Members

- Mark Bishop graciously volunteered to take on drafting of the financial policies.
- Rev. Jennifer will upload electronic copies of existing policies to Dropbox so that board members can review existing policies and ensure that any necessary content is included in the new policy drafts.
- Mark Bishop will reserve a room for the retreat.
- Board will review retreat schedule details at meeting in December.

## 5. Congregational Survey results and follow-up (Mark Bender)

- Mark Bender presented detailed analysis of survey results divided into relevant demographic categories.
- A summary of the results for the congregation will be published in a future Chanticleer by the end of the church year.

## **6. Sr. Minister's Report** (Rev. Jennifer Nordstrom)

- The Cass School parking lot space has been reduced to 30 to 35 cars. The parking task force is continuing to work on this issue.
- A new Communication Coordinator has been hired. Cindy Lorentzen comes to us with 20 years of communication experience.

- The KGAT team is sending letters to proposal applicants with follow up questions to be returned by Jan 8<sup>th</sup>. The KGAT team will provide a preliminary report to the board in January.
- RE Coordinator Cami Thomas and Sarah Richards, Chair of the Children's Religious Education Team is working with Rev. Jennifer to develop a search team for the Director of Religious Education search. The makeup of the search team will be shared with the Board at the December meeting.

- The board discussed the most relevant areas of expertise that would be useful as the nominating committee searches for potential board members.
