4. Kading Weiss Social Justice Project (Mark C.)

Tabled Motion: To take 40K out of the endowment to set aside for social justice causes, with no award less than \$20,000.

Discussed progress made on requests for proposals and bids for the air conditioning project, collaborating with the Social Justice Council and Anti-Racism Team to identify no more than two organizations to contribute to, and progress made on the endowment fund.

Motion to amend the original motion to read: "approve spending 10% of the remaining funds from the legacy gift after subtracting what the BOT previously approved to support no more than two social justice projects of no less than \$20,000 and as advised by the Social Justice Council."

Passed Unanimously.

5. Monitoring of 4.8 Senior Minister Well-Being (Jennifer)

Rev. Jennifer highlighted several points in her written report, including: taking a sabbatical and using the majority of her vacation time.

Jennifer highlighted several points of her written report, including: as of December 11, we have \$1,947,617 in pledges; the Membership Team is now the Welcome and Belonging Team; 18 registered for Journey to Membership; Anti-Racism Team, Social Justice Council and Trans Inclusion Teams planning to meet together to do leadership work within the congregation around protecting communities receiving the most vitriol; seeking support and interest in the revamped Immigration Action Team.

Anti-Racism Team (Amy) → looking forward to the MLK Day service discussion with the Wisconsin Black Historical Society; the Anti-Racism Team would like access to BLUU Box and Jennifer will email Jean to get access.

Treasurer Position (Stacy K.) → Stacy is touching base in January regarding the Treasurer position.

Annual Survey (Dana) → Dana says the Annual Survey is ready for distribution at the beginning of February. Dana and Stacey T. will encourage participation in coffee hour and

distribute paper copies. Will recruit others to help with survey participation encouragement. Dana and Stacey T. will create a signup and distribute it via email for survey recruitment.
