Bearing Witness and Standing Up for What is Right

The call from Norma Duckworth, Interfaith Coordinator of Voces de la Frontera, came 12 hours beforehand. Yessenia Ruano, a mother of nineyear-old twins, educator and immigrant member of our community

for 14 years had been called into the ICE office. This mother had committed no crime. She had shown up to every ICE check-in. She had worn a wrist GPS monitor until the skin had grown raw. When she walked into that office, she might not ever return but her worries were not about herself. What about her children? What about her students? How could she explain this to them?

When Norma asked if FUSM would accompany her to the ICE office and to bear witness, I said "Yes." UUs show up! Soon the press, the common council and Gwen Moore joined our call for decency, kindness and common sense. Ms. Ruano came back out from the ICE office. She attended her students' graduation and her daughters finished their school year. Ms. Ruano and her daughters self-deported with some autonomy and dignity. Milwaukee's loss highlights the current struggle. FUSM is proud to support, both logistically and financially, VDLF's Interfaith Coordinator Norma Duckworth and the struggle to keep families together. Splinters from the Board of Trustees

In May, the Board met early to complete the preparations for the Annual Meeting. In addition to approving the Annual Meeting agenda we requested and received input on the Memorial Trust Fund from the EFTF Trustees. They agree that it would make sense to move the funds of the Memorial Trust Fund into the Endowment Fund. The Trustees will work with the Board next year to continue this process. Dave Becker also gave details on the process and recommendations at the Annual Meeting. The annual budget was presented to the Board in April and after taking time to review the information was approved at the May meeting.

It has been recognized that the church fire and alarm system need updating for the safety of the congregation. A team has reviewed the current system and is looking for a single way to notify the congregation in an emergency. They have determined that a professional assessment is needed. The Board approved funds to move forward on this work. The Anti-Racism team is recruiting new members. They are working on the Juneteenth service and preparing an exciting speaker for the event. They are also planning trainings for next year, in Spring they will focus on interrupting racism and training on cultural competency in expected in Fall. One of the tasks for the board next year is a review of the church Ends. The Board approved hiring a consultant to assist with this task. The Ends give our congregation direction and intentionality in our actions. Please keep your eyes and ears open for exciting opportunities to participate and provide your voice in this process. Your input will help shape our future.

As I step down from the role of Board President I have much gratitude for the work of the past year. I am incredibly grateful for the wonderful Board and staff that I have been able to work with. And I am excited for what our future brings. While we are saddened with the departures of Rev. Dena and Steve, we are happy for the next steps in their journey. We are also looking forward to welcoming Rev. Long and his ministry.
